We are a credit broker of vehicle finance; we are not a funder or lender.

Please be aware your details may be passed over to a third party for finance, and/or to any necessary parties for the supply and delivery of your vehicle.

Processing Fee

We will charge a processing fee of £245 + VAT for our brokering services. Our brokering services include the administration undertaken by Express Car Leasing to arrange finance with the lender, source the vehicle and offer, securing and ordering the vehicle, providing updates on the progress of your vehicle order, and arranging delivery.

If you are a corporate client of Express Car Leasing and order more than five vehicles, we will not charge you a processing fee.

If you are a private individual, we charge a processing fee of £294 including VAT.

The processing fee is payable once your vehicle has been confirmed by the supplier and can be paid by bank transfer or cheque. This must be paid within 7 days of the invoice date. Should you wish to pay the processing fee by PayPal, any further fees are your responsibility and must be paid by you.

In the event of a cancellation the processing fee is not refundable, unless you are a regulated client (private individual, sole trader, or partnership with less than four partners) cancelling your vehicle order within the 14-day cooling off period, from the date of order confirmation.

Sourcing Fee

We will charge a sourcing fee for any vehicle sourced for outright purchase.

Cancellation Fee

If you choose to cancel our services, we will charge a cancellation fee as set out in our terms and conditions of £415.83 + VAT, £499 Including VAT for regulated customers (private individuals, sole traders, and partnerships with less than 4 partners)

This must be paid within 7 days of the invoice date. Should you wish to pay the processing fee by PayPal, any further fees are your responsibility and must be paid by you.
